Chairman Saldaña called the meeting to order at 1:00 p.m. Vice Chairman Sacks has turned in his resignation to the Board and now the Board is waiting on the Governor to fill the position

- New Market Service Center
  - Application of Deepak Kumar Garg, Anita Garg, & Jessica Leigh Wells to transfer New Market Service Center (MSDN, Inc) Class A-Beer license to a Class A-1 Beer, Wine & Liquor license, and continue to t/a New Market Service Center(MSDN, Inc), 29233 Three Notch Rd., Mechanicsville, MD 20659.

The above licensees appeared before the Board with Michael Davis representing them.

Member Currie made the motion to approve the upgrade of the current license and it was seconded by Member Palchinsky.

- Island Bar & Crabhouse
  - Application of Brian K. Norris to transfer Island Bar & Grill (Island Dining, LLC) a Class B (Restaurant) Beer, Wine & Liquor license from Bree Whitlock & t/a Island Bar & Crabhouse (SGICH, LLC), 16800 Piney Point Rd., Piney Point, MD 20674. And permission to include extension of premise & request for catering privilege.

Brian Norris appeared before the Board to transfer the license as the Old Line Bank is now the owner of the establishment. He is also requesting a 60 day conditional approval on the catering portion. Member Currie made the motion to approve the transfer and the conditional extension of premise approval thru September. Member Cullins seconded and the motion carried.

- Stone's Store
  - Application of Patricia Stone Oxley to transfer Stone's Store, a Class D-Beer, Wine & Liquor license from Patricia Stone Oxley & t/a Stone's Store (Stone's Store, Inc.), 26755 Stone Corner Lane, Mechanicsville, MD 20659.

Patsy Stone Oxley appeared before the Board to transfer the license from herself, the sole owner, to a Corporation. Member Palchinsky made the motion to approve the transfer and it was seconded by Member Currie. Motion carried.

- Heavy Hitters Bar & Grill
  - Application of Glenn E. Buckler to purchase a Class B (Restaurant) Beer, Wine & Liquor license & t/a Heavy Hitters Bar & Grill (GBS Entertainment, LLC), 30125 Three Notch Rd.,

Charlotte Hall, MD 20622. And requesting permission for extension of premise for smoking and horseshoes.

Dan Gunther appeared with Mr. Buckler requesting the purchase of a Class B license and an extension of premises. After confirming that Mr. Buckler's son, in no way is having any financial influence on the license, Member Cullins made the motion for the 30 day conditional approval and it was seconded by Member Palchinsky. Motion carried.

- Application of Donna Childers & Amanda Abell to purchase a Class B(Restaurant) Beer, Wine & Liquor license & t/a The Willows (The Willows Restaurant & Tavern, LLC), 24509 Point Lookout Rd., Leonardtown, MD 20650.

The applicants appeared before the Board for approval of the purchase of a Class B license. Member Palchinsky made the motion for a 60 day conditional approval and it was seconded by Member Currie. Motion carried.

- WJ Dent & Sons/Chief's Bar – Dave Dent

- Request for 60 day extension of conditional approval

Mr. Dent appeared before the Board requesting another 60 day conditional approval. Motion was made by Member Cullins and seconded by Member Palchinsky. Motion carried.

- Board Administrator – Tammy Hildebrand

The Board of County Commissioners approved the Grant Application that was submitted for training.

The State license has been approved for the Distillery.

Some of the populations have changed in the County so the limits for Liquor Licenses have changed. Some have gone up and some have gone down.

The office will be closed August 25 to August 30.

Chairman Saldaña stated that at the next meeting, there will be nominations for Vice Chair of the Board.

- Board Inspector – Tommy Thompson

Mr. Thompson has done 142 Inspections so far this year, 29 in the month of July.

- Retail Beverage Association

Mr. Dent said that Buck Distributing has made a large donation to the Retail Beverage Association to help fund the Topsy Taxi Program and it is very much appreciated. Mr. Dent also wanted to compliment and thank Deputy Stone for his work and training for the RBA.

Member Cullins moved to adjourn the meeting and it was seconded by Member Palchinsky. Motion carried.
