St. Inigoes General Store – Nora Blasko--Requesting 60 day extension of conditional approval

Guenther's Fine Wine & Spirits – Dan Guenther--Requesting extension of premise for alcohol storage

Mr. Guenther appeared before the Board for his request. He wishes to use 12X24 space behind his store for storage. Member Palchinsky made the motion for the 90 day conditional approval and it was seconded by Member Currie. Motion carried.

Anchorage 93 – Ernest Bernich & Stephen Schuyler -- Requesting extension of premise for 16' x 24' pavilion

Mr. Bernich appeared for himself and on behalf of Mr. Schuyler requesting the extension of premise. He and the other license holder did not know they were not in compliance with the ABB laws regarding the outdoor pavilion they use for the smokers. It is a fenced in car port like area that the smokers can carry their drinks outside. Signs are posted. Member Currie made the motion to approve the extension and it was seconded by Member Palchinsky. Motion carried.
