<p>This award recognizes excellence in the preservation and restoration of historic buildings, interpretation of architectural features in new construction, and adaptive reuse of historic structures. Judging standards include architectural integrity and compatibility, successful adaptation or use of historic structure, quality of construction, craftsmanship, or technical excellence. All nominated projects must be located in St. Mary's County and <b><u>must have been completed by December 31, 2022.</u></b></p>

<p>This award recognizes outstanding achievement in and support for furthering the aims of historic preservation in St. Mary's County, including: education, research, development, planning advocacy, and community leadership. Individuals, businesses, and organizations are eligible.</p>

<p>This award is given to a recipient who has dedicated many years of their life to a worthy preservation cause, and made an impact to preservation efforts in St. Mary's County. Work must span a period of time no less than twenty (20) years and can include various projects accomplished throughout the years.</p>
