For Master electrician exam, the applicant shall not show less than seven (7) years of experience preceding the date of the application, under the direction and supervision of a master electrician, three (3) years during which the applicant supervised or was actively in charge of electrical installation work. The Board may credit not more than three (3) years for formal course study or professional training in electrical installation, where applicable.**

**For all exams, along with the exam application the applicant is required to include copies of other licenses held, certificates of training, and notarized copy of experience validation by current and past employers.**
