

RESOLUTION

WHEREAS, on March 10, 1992, the Board of County Commissioners for St. Mary’s County, Maryland, adopted Resolution No. W/S 92-01, amending the Comprehensive Water and Sewerage Plan to reclassify the Sewer service category for St. George’s Island; and

WHEREAS, the said Resolution No. W/S 92-01 limited new sewer facilities on St. George’s Island to 219 equivalent dwelling units (EDUs) as described in an attachment to Resolution No. W/S 92-01; and

WHEREAS, on March 10, 1992, the Board of County Commissioners for St. Mary’s County, Maryland, entered into an agreement with the St. Mary’s County Metropolitan Commission and the St. George’s Island Improvement Association restricting service to St. George’s Island to 219 equivalent dwelling units (EDUs); and

WHEREAS, the Board of County Commissioners for St. Mary’s County, Maryland subsequently adopted resolutions modifying Resolution No. W/S 92-01 and the allocation of EDUs to St. George’s Island as follows:

WHEREAS, Piney Point Road, LLC is the owner of property identified as Map 66, Parcel 52, Lot 500-1, having a street address of 16934 Piney Point Road, Piney Point (on St. George’s Island), Maryland; and

WHEREAS, the said property was entitled to an allocation of one (1) EDU but was inadvertently omitted from the provisions of Resolution No. W/S 92-01; and

NOW, THEREFORE, BE IT RESOLVED, by the Commissioners of St. Mary’s County that Resolution No. W/S 92-01 is amended to allocate one additional EDU to Lot 500-1 for a total of 238 EDUs for St. George’s Island.

BE IT FURTHER RESOLVED, by the Commissioners of St. Mary’s County, that this Resolution shall be effective upon the date written below.
