A limited number of booklets are available and will be distributed on a first come, first served basis. Checks must be redeemed by Nov. 30, 2019.

Proxy

A proxy designation may be completed if a participant cannot attend distribution. Proxys may apply on behalf of a participant, provided the following documentation is provided on the day of distribution:

- A completed copy of the current SFMNP application, signed by the eligible senior participant
- A copy of the senior participant's residency ID
- The proxy's photo ID

*proxy forms are available for pickup at the Garvey Senior Activity Center beginning in June. Sending a proxy to the distribution does not guarantee check receipt. Checks are available first come, first served.

New this year – for your convenience, produce from Porpoise Creek Farms will be on the Governmental Center Campus on the day of distribution. Get your checks and redeem all in one location!
