Public Forums provide residents an opportunity to speak directly to the Commissioners on topics of their choosing. In addition, residents may offer appreciation, questions or suggestions in a mutually respectful format.

Meetings are accessible to the public as long as social distancing guidelines can be maintained and the Commissioners Meeting Room capacity limits do not exceed 33.
